PRESIDENT'S REPORT: Dr. Taylor reported that he had been selected as a representative from Region X of HEW on Energy Projects.

Region X represents Alaska, Washington, Oregon, Idaho and Nevada. The Governor has also asked him to serve on a state Energy Commission.

Dr. Taylor reported on the meeting of the Assocation of Community College Trustees in Detroit and the benefits derived from such meeting. He indicated that one speaker had advocated federal government accreditation of colleges and universities. Dr. Taylor sent night letters to a number of congressman opposing this idea or concept. Mr. Blastock reported on some of the collective bargaining problems that are facing higher education.

Dr. Taylor reported that the energy projects at the College are still progressing and that the geothermal well could be drilled approximately 100 feet more with the present cable rig. He also reported that surplus metal had been found in Boise for construction of a tower for a windmill.
