

INTERNATIONAL STUDENT Certificate of Financial Responsibility

PLEASE READ CAREFULLY BEFORE COMPLETING THE CERTIFICATE OF FINANCIAL RESPONSIBILITY.

The United States Immigration and Naturalization Service requires an international student to show evidence of adequate financial support for one full academic school year and a plan for continued funding for the subsequent year. Please complete the following form to the International Student Office with your application materials.

Certificate of Finance is completed and signed by an individual who is sponsoring your education, all information must be accurate. Bank Account must have been active for at least 6 months.

Official Bank Statement/Transactions sent from the bank which indicates that there is at least **\$20,167.00** available to meet educational expenses for your first academic year exclusive of travel.

When calculating your expenses, please consider the following factors:

1. Students in F-1 status are only permitted by U.S law to work only under certain limited circumstances.
2. Employment opportunities at the College of Southern Idaho or Twin Falls area are very limited.
3. The College has limited forms of scholarships to assist in meeting your educational expenses.
4. While you are enrolled at the College of Southern Idaho, we discourage you from depending upon employment as a major source of financial support.

Students are required to pay an advance deposit fee of \$2,500 for their first semester before being able to register for classes.
